### INSTRUCTIONS FOR SMOOTH VC HEARINGS

- Upon clicking the "Join" button, the party would be prompted to enter the display name wherein the party is required to write his/her name with designation by prefixing item no. (of the cause list) in the space given i.e.: ITEM NO. 1 – ABC - Appellant OR ITEM NO. 1 – DEF - Respondent OR ITEM NO. 1 – GHI - PARTY-IN-PERSON, as the case may be, and thereafter the party is required to click on the "JOIN" button.
- 2. After joining, ensure that VIDEO is always on OFF mode AND MIC is always on MUTE mode.
